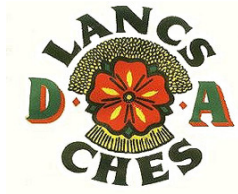

WHILST ON SITE

- ✓ Keep to the governments social distancing guidelines such as 2 metres where possible and 1 metre plus appropriate PPE where 2 meters can't be adhered to.
- ✓ No social gatherings - you must comply with the local area requirements for meeting as groups. If you have a bubble then please be aware of others around you and stick to at least 2m apart when outside your social bubble.
- ✓ No gazebos or party tents allowed on site
- ✓ No organised activities will be allowed outside your bubble; if anyone is found to be trying to organise any they will be asked to leave.
- ✓ You will need to provide your own hand sanitiser, masks and gloves.
- ✓ Use disposable gloves and disinfectant at both elsan and drinking water taps before and after touching and consider washing your hands back at your unit.
- ✓ Only adults are permitted to use water taps
- ✓ Parents/Grandparents/Guardians are responsible for the behaviour of children in their unit
- ✓ **TENTS** – groundsheets/tarpaulin must be used under toilets to stop contamination of ground for future campers
- ✓ No day visitors allowed
